Contribution Rules

This campaign is participating in the New York City Campaign Finance Program therefore the following rules and requirements apply.

New York City Council Race:

- Only contributions from New York City residents (*all five borough*) are eligible for NYC campaign matching funds
- Minimum amount eligible for matching funds **\$ 10.00**
- Maximum amount eligible for matching funds **\$ 175.00**
- Each person listed on a joint account is eligible to contribute to and qualify as an individual contribution. Separate contribution forms with separate checks need to be submitted for record keeping purposes.
- The maximum amount for any individual * contribution is **\$ 2,750.00**
- NYC campaign finance program will match all qualifying contributions raised 6 to 1
- Contributions **can** be accepted from non NYC residents, and sole proprietorships. These contributions are limited to **\$2,750.00** and are not eligible to receive NYCFB matching funds
- A maximum contribution of **\$250** is limited to persons **doing business with the City of New York** and the contribution is not eligible for matching funds.
- Contributions **cannot** be accepted from Corporations, Partnerships, Limited Liability Partnerships (LLP's) and Limited Liability Companies (LLC's), Professional Corporations (PC's), Subchapter S Corporations, etc.
- Contributions **cannot** be accepted from political committees unless they are registered with the NYCCFB

* **"Any individual"** includes US citizens or permanent residents living in the US
